<b>Summary of membership:</b>	<p>A <b>SOAC Membership</b> includes use of use of pool &amp; fitness amenities, plus the use of the tennis courts WITH ADDITIONAL COURT FEES. <b>\$5.00 per person for court usaae.</b></p> <p>A <b>SOAC Full Play Membership</b> includes use of pool &amp; fitness amenities, plus allows for participation in ALL TENNIS activities and first priority on tennis court schedule. To participate in USTA or Club leagues through SOAC, members must be a Full Play Member.</p> <p><b>Family members must live in the same household and may include the husband, wife, and all unmarried children 21 and under (grandchildren are not eligible). All children who use the facility must be included on the membership. Members must be 14 years of age or older to use the gym and/ or pool without a parent.</b></p>
<b>Guest Policy:</b>	Guest, if accompanied by a member, can pay a fee of \$10. <b>All Guest are limited to 5 times per year.</b>
<b>Suspension of Membership:</b>	Members can only suspend membership for health reason. A doctors note must accompany written notice. <b>MAX suspension is 2 months. A months notice is still required to cancel membership.</b>
<b>Membership change:</b>	Members will be charged a \$25 administration fee if the membership type is changed. Membership change can ONLY BE MOVED UP during contract period.
<b>Cancellation of Membership:</b>	<p>ALL MEMBERSHIPS REQUIRE A WRITTEN NOTICE IN ORDER TO BE CANCELLED. <b>If you wish to discontinue membership after the contract minimum, we require a written notice, and your membership will end on the last day of the notified month. <b>Monthly Payment:</b>	Dues & Account Balances can be paid in one of the following ways: Cash, Check, or Auto Draft (Credit Card or Checking Account). Account reminders are sent via email on the LAST day of the month. Payments are due by 7:00pm on the 1st of the month. Account balances as of 7pm on the 1st will be paid via Auto Draft of Credit Card or Checking Account.
